IB Regulations :

The minimum number of subsets for rebate calculation and payment is 5 individuals. The minimum trading volume size required for IB performance calculation is 30 lots. Only one side of trades with hedging will be considered for calculation. Trades below 30 lots will not be considered for IB calculation. Add a minimum of one new subset every three months. Rebate will not apply to trades under 2 minutes. Withdrawal of funds is possible at the end of the month.
